Charging and Remissions Policy



The Governors and staff are committed to the principle of high quality education being provided free of charge.

Budgetary restrictions, however, are such that there are activities of sound educational value which cannot be funded by the school alone.

Aim

To promote a wide range of activities as part of a broad and balanced curriculum and as additional activities.

- Charges will not be made for any activities which are in fulfilment of National Curriculum requirements.
- Activities which occur mainly within school hours will not normally be chargeable. However, there is a charge for group or individual music tuition if this is not part of the National Curriculum.
- In practical/craft activities, parents may be asked for the full or partial cost of materials or ingredients if they wish to own the finished product.
- When organising educational visits, the school invites parents to contribute to the cost of the trip. All contributions are voluntary.
- Parents will be asked to pay for the residential costs of off-site activities and may be asked to make contributions to cover cost of travel and organised activities.
- Where an activity cannot be sufficiently funded it may have to be cancelled and this will be made clear from the outset.
- Parents may be asked to pay for or towards the cost of making good damage to or loss of school property, e.g. defaced books, a broken window where this is the result of the child's behaviour/negligence, lost library books.
- Requests from parents for financial help and assistance will be sympathetically considered in consultation with the Head and Chair of Resources Committee. Complete confidentiality will be observed in such matters.

The following is a list of additional activities organised by the school which may require voluntary contributions from parents:-

- sporting activities which require transport expenses;
- visiting theatre companies or visits to the theatre;
- musical events.
- The school organises swimming lessons, for children not meeting National Curriculum expectations, these take place in school time and are part of the National Curriculum. Charging and Remissions Policy 2023-2025.23

We make no charge for the lessons but we do ask for a voluntary contribution towards the cost of transport.

• Afterschool Clubs organised by outside companies will set their own charges to be paid in advance. Refunds are not given for missed sessions.

Remissions and concessions

In line with the Department for Education policy on Charging for school activities, the school ensures all parents on low incomes and in receipt of the benefits listed below will be informed of the support available to them when being asked for contributions towards the cost of school visits – including that those children will be exempt from the cost of board and lodging. The school will also give consideration to the remission of charges to parents or carers who receive the following support payments:

- income Support
- income-based Jobseeker's Allowance
- income-related Employment and Support Allowance
- support under Part VI of the Immigration and Asylum Act 1999
- the guaranteed element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on paid for 4 weeks after you stop qualifying for Working Tax Credit
- Universal Credit if you apply on or after 1 April 2018 your household income must be less than £7,400 a year (after tax and not including any benefits you get).

Children of families who receive these payments are also entitled to free school meals. If your child is eligible for free school meals on the basis of Universal Credit, if your income rises above the threshold your child will remain eligible for free school meals until they finish the phase of schooling (primary or secondary) they're in on 31 March 2024.

Parents who are eligible for the remission of charges will be dealt with confidentially.

The Headteacher and Chair of Governors will authorise the remission of charges.

The school may choose to subsidise part or all of the payment of some charges for certain activities and pupils, and this will be determined by the Governing Body and Headteacher.
